4. All contestants will be barbecuing one pork butt and one rack of ribs.
5. The Milford Commercial Club will provide the meat to each contestant.
6. Contestants may use wood, charcoal or gas.
7. Electricity will be available upon request. Prior notice required.
8. Turn in time to the judges is 4 p.m.
9. Garnish is optional. If used, it is limited to chipped, sliced, shredded, or whole leaves, fresh green lettuce, curly parsley, flat leaf parsley and/or cilantro, kale, endive, red tipped lettuce, lettuce cores and other vegetation are prohibited. Improper garnish will receive a score of (1) on appearance.
10. Milford Commercial Club will sell tickets to the public to sample the contestants barbecue to benefit the Pioneer Days celebration. Public serving will take place from 5 p.m. until gone. Contestants are required to furnish a small table, cutting board and knife. Winners will be announced after public tasting.
